PLEASE TAKE NOTICE that sealed bids will be received by the Joint Board of Fire Commissioners, Township of Brick, for the provision of temporary work and educational space, inclusive of delivery and installation, for a fire training center on Wednesday, April 3, 2019, at 5:00 p.m. prevailing time at the Joint Board Office located at 253 Brick Boulevard, Brick, New Jersey, at which time they will be opened and read by the Joint Board Clerk or designated representative.

A mandatory Pre-Bid Conference shall be held on Thursday, March 21, 2019, at 10:00 a.m. at the Brick Township Fire Training Academy, 500 Herbertsville Road, Brick, New Jersey.

Bids must be enclosed in a sealed envelope marked "Temporary Work/Educational Space" on the outside addressed to the Joint Board of Fire Commissioners, Township of Brick. The bid must be delivered to the Joint Board Office located at 253 Brick Boulevard, Brick, New Jersey, at 5:00 p.m. on April 3, 2019. If mailed, all bids must be mailed by Certified Mail to the Joint Board of Fire Commissioners, Township of Brick, 253 Brick Boulevard, Brick, New Jersey 08723, and received on or before the above set forth time and date.

No bid will be considered unless in writing on the form furnished.

Bids may not be faxed, transmitted over the telephone or emailed. The Joint Board of Fire Commissioners, Township of Brick, assumes no responsibility for delays in any form of carrier, mail or delivery service causing the bid to be received untimely.

Bidders must submit with the bid a "Statement of Ownership (Ownership Disclosure Certification)" and a "Non-Collision Affidavit" on the forms included in the bid package.

Bidders must submit proof with the bid of registration with the New Jersey Department of Treasury, Division of Revenue, by submitting a copy of bidder's Business Registration Certificate.

Pursuant to N.J.S.A. 10:5-31, bidders are required to comply with the requirements of P.L. 1975, c.127, N.J.A.C. 17:27.

The Joint Board of Fire Commissioners, Township of Brick, reserves the right to reject any or all bids not deemed to be in the best interest of the Township.

It is the purpose of the Notice to Bidders to summarize some of the provisions of the bid documents. Prospective bidders are cautioned not to rely solely on this Notice but to read the bid documents in their entirety.
